Guidance Notes

1. The purpose of a risk assessment is to reduce the *risk and likelihood of injury* to any person as far as reasonably practical
2. The types of risks you are assessing are *reasonably foreseeable*
3. The use of petrol generators at Daventry Farmers Market is strictly prohibited
4. You must inform Daventry Town Council in writing of any changes to your risk assessment
5. Please ensure you send a copy of your insurance and relevant supporting documentation, for example, Health and Safety Policy, Food Safety Certificates
