Cllr Knape highlighted that West Northamptonshire Highways had confirmed that they would cut back vegetation and install signage warning motorists of pedestrians at regular crossing points used on Welton Lane, but that they would not be reducing the speed limit of the road which should remain at 40mph. Cllr Knape advised members of the availability of a grant from the OPFCC to purchase mobile speed signs which could be used in this area and others within the town, and it was

TC2404.9 DAVENTRY HERITAGE TRAIL

Members referred to the report in relation to the Daventry heritage trail information boards and heritage plaques project.

Members questioned the size and need for multiple information boards containing the same information and concurred that four boards would be too many and the size and design should be incorporated in the Daventry Town Masterplan, to ensure that its introduction would complement the revised street scenes and it was

Members further considered the request for the Town Council to accept responsibility for the care and maintenance of engraved lettering into the paved area outside of Windsor Lodge, due to the Local Planning Authority refusing approval for a blue plaque on this building, and it was

	and maintenance, the Town Council does not accept responsibility for the
	pavement engraving recognising the history of Windsor Lodge.

TC2404.10 SECTION 17 CRIME AND DISORDER ACT 1998.

(i) COMMUNITY POLICING. The Sponsored PCSO spoke to her report, highlighting the various engagement activities that she had undertaken through the month of April; a monthly surgery, community litter pick, crime prevention talks for a local community group, Services Day on the Southbrook estate, and the OP UNITE event.

PCSO Teagle further advised that their focus for the month of May would be on the use of e-scooters, and police would be working with West Northamptonshire Council to provide an education programme to present to schools to highlight the current legislation surrounding the use of e-scooters which is often not provided when they are purchased.

- (ii) **COMMUNITY SAFETY.** Members noted the report from the Community Ranger.
- (iii) **CCTV.** Members noted that the report on analysis trends relating to community safety was not available.
